Letter sent to Representatives urging them to join the Americans Abroad Caucus

Re: Dear 535 Campaign

Dear Representative,

Millions of Americans live abroad. They have left the U.S. for many reasons, such as to be with a life partner, to study or to follow a job opportunity. Some retirees move to a place with a more affordable cost of living. Contrary to stereotype, most Americans abroad are of modest or moderate incomes. They retain links to the United States through family, property, voting, taxation, businesses, retirement plans and banking and investment accounts.

But, for many, their dreams, professional prospects and even love stories end up in distress.

They face legal and regulatory incompatibilities that result in unfair taxation, impediments to their retirement planning and loss of their investment and bank accounts. They have high compliance costs, lack of local job opportunities, the inability to run small businesses, and so on. That translates into stress, fear and worry. "When is this nightmare ending?" Family relationships are affected. For some the only solution is a painful and expensive renunciation of citizenship. "It breaks my heart!"

Many feel neglected: "I think they don't have any understanding of the problems we must deal with" and "I feel that the US doesn't care about me except to view me as a criminal."

Our two organizations, SEAT and AARO, which advocate for Americans overseas, asked respondents in two recent surveys to comment on their lives abroad. We received thousands of heartfelt and emotional responses, some of which you see above. In this "Dear 535 Campaign," we are sending each of you in Congress some of this testimony from your constituents. Please see the next page. Each set of comments is different so we invite you to look at your colleagues' comments for a fuller picture.

Overseas Americans do not demand privilege or special treatment; they only ask to live ordinary lives like resident Americans. But many cannot due to laws, regulations and practices that fail to respect the American values of equal protection and due process. Eliminating the burdens and discriminatory treatment due to non-residence may be a challenge, but it can be done.

You can become part of the solution by joining the bipartisan Americans Abroad Caucus (Chair, Dina Titus D-NV) and supporting the legal reforms necessary to allow overseas Americans to live ordinary lives. You will continue to hear from us about the problems faced by Americans abroad.
